Plan to make a Difference!

The **Endowment** represents a long-term commitment to the life of this church and to the lives of future generations.

The earnings from the **Endowment** are used for:

Earnings are **NOT** used for the regular and recurring operating expenses of the church.

All gifts are welcome at any time. Listed are some options to consider:

Remember the Endowment in Your Will or Trust.

Leave a lasting legacy with a gift through your estate plan. You can gift a specific amount, a specific asset or a percentage. Contact the church office to receive helpful information, including sample bequest language to share with your attorney.

Appreciated Stock

This is an easy and cost-effective way to give. For maximum tax savings, the stock must be transferred directly to the church. For easy transfer instructions, call the church office or your Missouri United Methodist

Charitable Gift Annuity

You receive a current income tax deduction and an annual fixed payment for life, or two lives jointly. Very attractive rates for seniors and your church receives the remainder.

Charitable Remainder Trusts

Particularly useful for large gifts of appreciated assets (land or stock). Provides income for a lifetime or term of years—remainder to the church/charities.

Life Estate

Donate your home or farm today, but retain full ownership during your lifetime. This creates a current tax-deductible gift and can simplify estate plans.

Beneficiary Designations

Name the church as the beneficiary of an **IRA**, an insurance policy or other assets. This is an easy way to support future ministry.
